RECALL REGULATION

1 Authority

- 1.1 This regulation is made pursuant to the *Recall Law*.

2 Definitions

- 2.1 Unless specifically provided otherwise in these regulations, the terms used have the same meaning as defined in the *Recall Law*.

“**Law**” means the *Recall Law*;

3 Recall Petition Application Process and Form

- 3.1 The application for a recall petition process must begin with a written submission in the prescribed form to the Chief Administrative Officer of the Tla’amin Nation.
- 3.2 The *Recall Petition Application Form* (Schedule 1) is prescribed for a recall petition application under the Law.
- 3.3 No recall petition application will be invalidated by the Chief Administrative Officer or their delegate merely because it is not made using the prescribed form, so long as the form that is used is substantially similar to the prescribed form and meets the minimum requirements for a recall petition application identified in the Law.
- 3.4 The Chief Administrative Officer of the Tla’amin Nation or their designate will receive all completed *Recall Petition Application Forms* and will determine whether the application to recall an elected official of the Tla’amin Government will be granted or declined.

4 Recall Petition Process and Form

- 4.1 If the Chief Administrative Officer or their designate decides that an application for a recall petition meets the requirements under the Law, the Chief Administrative Officer or their designate must issue a recall petition in the prescribed form.
- 4.2 The *Recall Petition Form* (Schedule 2) is prescribed for a recall petition under the Law.
- 4.3 No recall petition will be invalid merely because it is not made using the prescribed form, so long as the form used is substantially similar to the prescribed form and meets the other requirements of the Law.
- 4.4 Each page of a recall petition containing signatures must also contain at the top of the page the necessary information identified in the *Recall Petition Form*.

5 Commencement

- 5.1 This regulation is deemed to have come into effect on April 5, 2016.
